3. OFFICE:

Office of the trust shall be at building number X/268 of Kattakampal Panchayath, Thalappilly Thaluk, Thrissur District, Kerala.

4. AREA OF OPERATION:

Revenue District of Thrissur - kerala

5. AIMS AND OBJECTIVES :

- A. To establish and maintain :-
- Educational institutions such as pre-primary, primary, Secondary and Senior
 Secondary Which provide excellent academic education to the children, and colleges, to provide higher education to the youth.
- 2) Technical educational institution such as Industrial Training Centre (ITC):
 Poly Technical, Engineering Colleges to provide high-tech trade oriented technical education to the growing generation.
- Modern computer laboratory to provide better training in the Information
 Technology (IT)
- 4) Excellent Library reading rooms having modern useful books and periodicals to provide ample opportunities to read, refer and study every section of the society.
- 5) Good language laboratory to have a modern outlook to the students as well as teachers
- 6) Community Hall to conduct conferences, meeting, seminars, debates, art, literary and cultural activities.
- Self financed universities having all the modern facilities.
- 8) Residential educational institutions for deaf and dumb; and other disabled children.
- 9) Orphanages to protect and nourish the orphans in the society.
- 10) Endowments for providing scholarships and other useful essential financial

- Health clinics, dispensaries, nursing homes and hospitals to provide better treatment and nursing to the patients and also to conduct free pain palliative camps, medical camps, blood testing camps and prepare a core group to donate blood to the needy patients.
- B. To organize and conduct athletic meet, sports and door and indoor games for development of physical and mental health of the lads.
- C. To make aware the people especially illiterate and ignorant about the moral values of life and to abide by the rules and regulations of the constitution of our nation.
- D. To propagate against the taking of the liquors and other narcotic things.
- E. To Work for promoting and implementing the unity, integrity, communal harmony, secularism, and national solidarity and keep up the cultural heritage of the nation.
- F. To focus and execute the overall development of Muslim Minority's Education.
- G To plan and Implement all necessary steps for improving Higher Education of Muslim community Girls, likely, hostel facilities, Study centre, Scholarship, Self Entrepreneurship etc.

6. NOW THIS DEED WITNESSETH AS FOLLOWS:

The trustee should possess the below said sum Rs. 15,000(Rupees fifteen thousands only) and any other assets which may hereinafter be received by them for the purpose of the trust hereinafter mentioned (all of which are hereinafter included in the expression the "Trust fund") and to apply the same for the furtherance of the objectives of the trust in proper and in accordance with this DEED and subject to the powers and provisions hereinafter confidence.

7. GENERAL BODY:

- A. A person can become a member of the trust' if he applies in the prescribed application form of the trust and the working committee accepts the membership unanimously and with at most confidence.
- B. The members shall be required to remit subscription, membership fee and monthly fee, the amount of which shall be decided by the working committee.

- C. A member shall lose his membership if it is proved that he does any act which is contrary to the objectives of the Trust and the majority of the members of the working committee, demands the dismissal.
- D. The working committee shall be elected once in every three years at the general body meeting of the Trust. If the working committee is found inefficient and 2/3 of the body members demand in writing, the new working committee shall replace the existing working committee before the expiry of the prescribed duration of the existing working committee.

The General body meeting of the Trust shall be held once in a year. Notice for convening general body meeting shall be issued one week before the meeting. More than half of the total number of members shall be present at the general body meeting which elect the working committee.

E. The general body having three-fifth majority has the power to make new rules and regulations and to amend any existing rules and regulations and to make sub rules as per the decision or will.

8. WORKING COMMITTEE:-

A. The number of general body members of the Trust shall be 21 out of which committee consisting of a maximum number of 15 shall be elected in every 3 years at a general body meeting of the Trust.

POWER AND DUTIES OF THE BOARD OF TRUSTEES:

The administration of the Trust shall vest with the Board of Trustees and the Managing Trustee shall on behalf of the Board of Trustees carry out the day administration of the trust. However, immovable properties of the Trust can be sold, transferred or alienated only with the decision of the two third majority of the Board of Trustee.

11. POWERS AND DUTIES OF THE MANAGING TRUSTEE (CHAIRMAN)

- 1) Convene the meeting of the Board of Trustees.
- 2) Conduct the day to day administration of the Trust.
- 3) Appoint necessary employees and professionals and administer their services.
- 4) Represent the trust in all legal proceedings and before all authorities if and all matters relating to the Trust.
- 5) Execute all documents for and on behalf of the Trust.
- 6) Operate the Bank accounts of the Trust solely as decided by the Board of Trustees.
- 7) Signing and receiving all documents and minutes relating to the committee.
- 8) The process of making, buying and selling of the movable and immovable on the ultimate decision of the Board of Trustees.
- 9) Maintain the books of accounts of the Trust. Prepare the income and expenditure statements and balance sheet of the trust so as to get the said accounts audited.
- 10) Raise loans by pledging the properties.
- 11) The power to take final decision in all Trust matters.
- Sub committees for any specific purpose shall be constituted by the chairman and he can disperse such committees at any time as the occasion demanded.
- 13) The power to give necessary publicity of the trust activities.
- 14) To receive and give back the debts, where ever necessary for the Trust.

13. The Capital of the trust be 15,000 Rupees(Fifteen thousand Rupees)

MEETING OF THE BOARD OF TRUSTEES

- The board of the trustees shall meet as after as required and shall meet at least once in three month. The meeting shall be presided by the chairman and in his absence by a trustee elected by members of the meeting attended as chairman, for the days meeting.
- The quorum of the Board of Trustees meeting shall be one third of the total strength. In the absence of quorum, the meeting shall be adjourned to the next week on the same day, same time and place of the next week. At the adjourned meeting, members present shall constitute the quorum.
- Managing trustee shall convene the meeting, draw up the minutes and get the same approved in the next Board of Trustees can also be adopted by circulating the required resolution among the members of the Board of trustees and obtaining their consent.
- 4) Notice for conducting meeting should be served to each and every member three days before. However emergency meeting may be convened with shorter period of notice whether written or oral.

15. ADVISORY COMMITTEE

The Board of trustees from an Advisory Committee with comprises professional, scientific and religious men, not more three.

16. RESIGNATION/RETIRMENT/DISMISSAL OF TRUSTEES

A Trustee may resign/retire at any time after giving seven days notice in writing to be Board of Trustee of his own desire to do so. Complaints if any against any Trustee in dealing with Trust fund shall be initially dealt with chairman of the Board of Trustees. In the matter of removing a Trustee from his position, a resolution shall be passed by 2/3rd

INCOME OF THE ACCOUNTS

- A The trust can accept funds of this for its activities form of donation, charity and loans from India and abroad in accordance with the constitution of Government of India.
- B All properties which are donated to the trust, and acquired by the trust shall be in the name of chairman for and on behalf of the trust
- C The fund of the trust shall be used only for the charitable purposes.

18 AUDIT OF THE ACCOUNTS

The financial year of the trust shall be from 1st April to 31 st March of every year. The account of the trust should be audited by a chartered accountant. Every year the board of trustees shall appoint a qualified chartered accountant as the auditor of the trust and fix his remuneration. The audited accounts of the trust shall be adopted by the board of trustees within 30th September of the next financial year.
